## DAILY COVID-19 UPDATE

April 20, 2021

Since Congress and the White House have shifted focus to a broader set of policy issues, we will be pausing distribution of the Daily COVID-19 Update starting this Friday, April 23. However, we will continue to include COVID related health and economic updates in our Daily Dose and the Financial Services Week Ahead.

### WHAT HAPPENED TODAY

Today, Johnson & Johnson announced it will resume distributing its COVID-19 vaccine in Europe after the region's medical regulator found the benefits of the vaccine outweigh the risk of the rare blood clots. However, the European Medicines Agency (EMA) recommended adding a warning to the vaccine's product label regarding the rare side effect. Johnson & Johnson's Chief Scientific Officer Paul Stoffels stated that he "hope[s] by making people aware as well as putting clear diagnostic and therapeutic guidance in place," the company can restore confidence in the vaccine.

Yesterday, the Consumer Financial Protection Bureau (CFPB) unveiled a new rule aimed at stopping debt collectors from forcing renters from their homes during the nationwide eviction ban. CFPB Acting Director Dave Uejio stated the agency will

"hold accountable those debt collectors who move forward with illegal evictions." Currently, about 9 million tenant households are behind on rental payments as the eviction moratorium is scheduled to expire on June 30.

- Rep. Fred Keller (R-PA) introduced the Saving Hypodermic injections and Offering vaccines to Taxpayers Swiftly (SHOTS) Act. This [legislation](#) would instruct the Department of Homeland Security to ensure that American citizens and lawful permanent residents are given priority to receive the COVID-19 vaccine over those visiting or who have entered the United States illegally.
