

EQUIPMENT FINANCE INDUSTRY IN MARYLAND

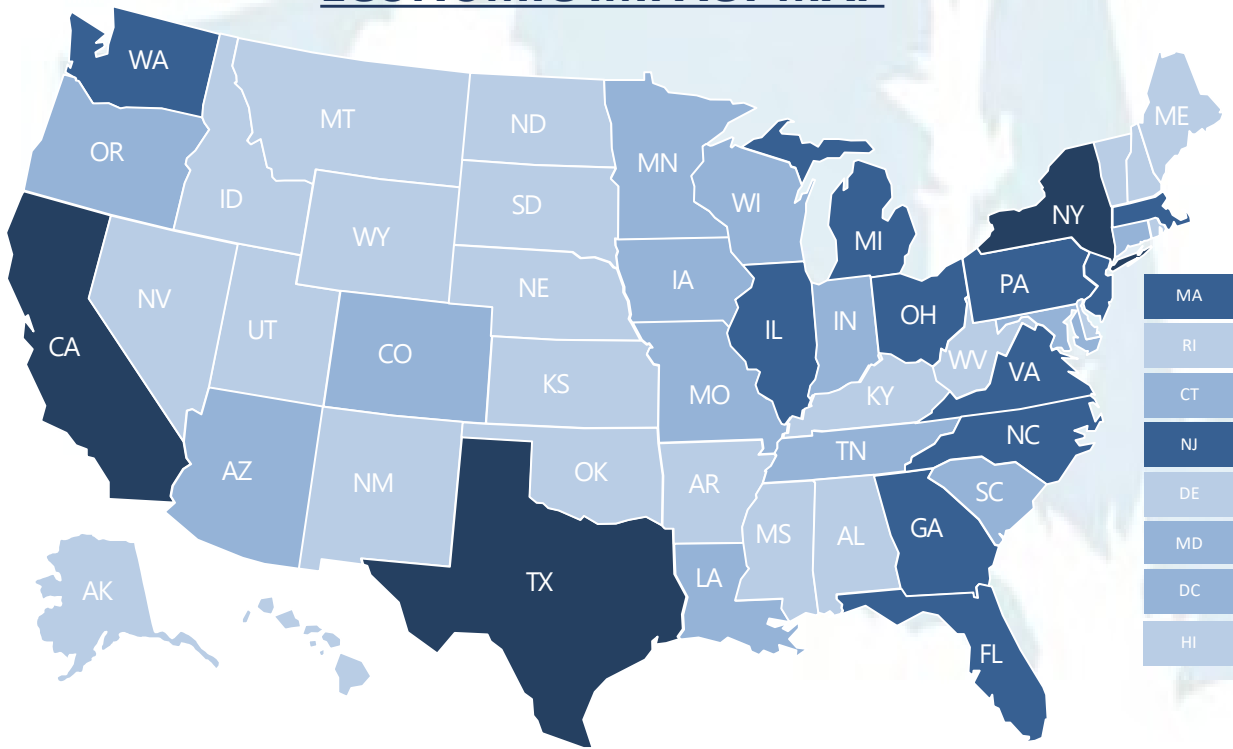
In the U.S. over **\$1 trillion** in capital goods is financed through loans, leases, and other financial instruments.

Maryland is aiming to reach net-zero emissions by 2045.*

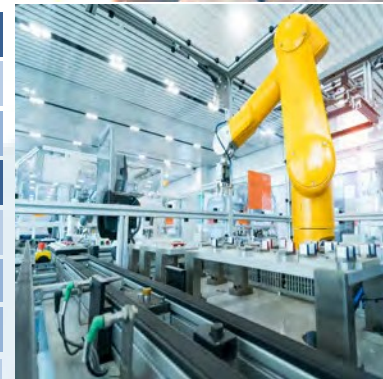
ECONOMIC IMPACT MAP
