

EQUIPMENT FINANCE INDUSTRY IN NEW YORK

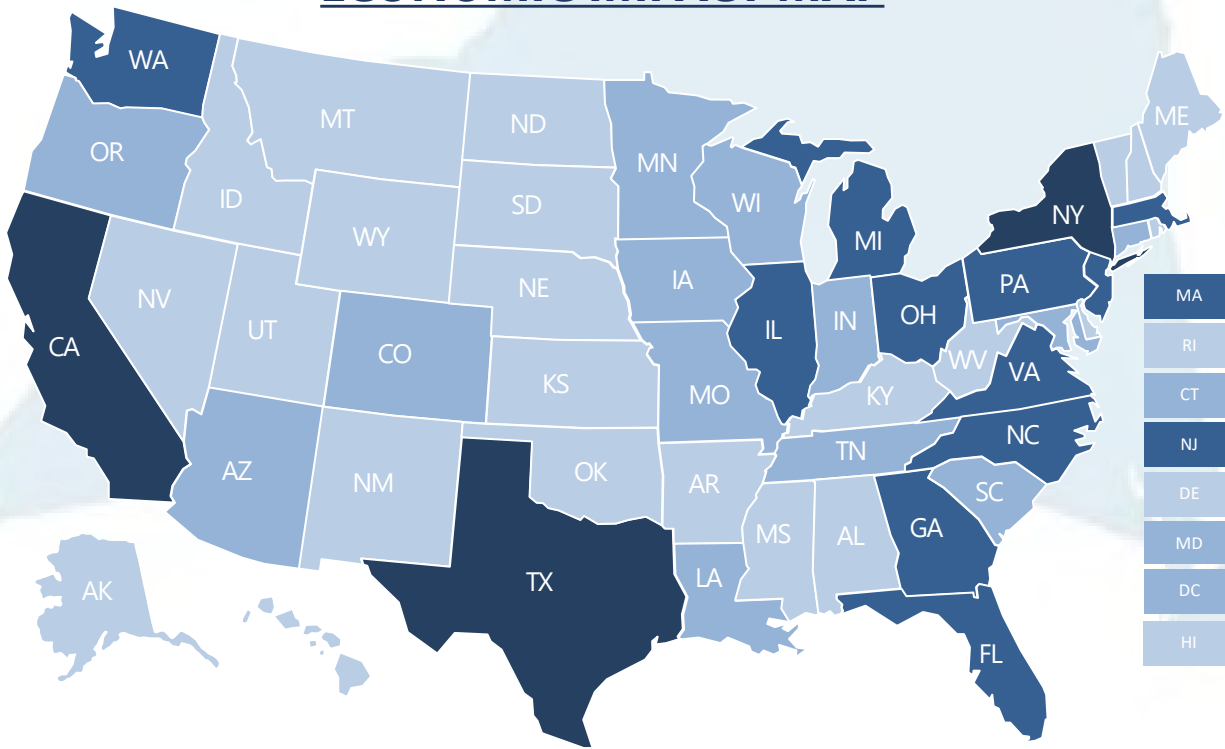
In the U.S. over **\$1 trillion** in capital goods is financed through loans, leases, and other financial instruments.

Businesses in the State of New York financed **\$106.3 billion** in capital equipment in 2022.
