

EQUIPMENT FINANCE INDUSTRY IN TENNESSEE

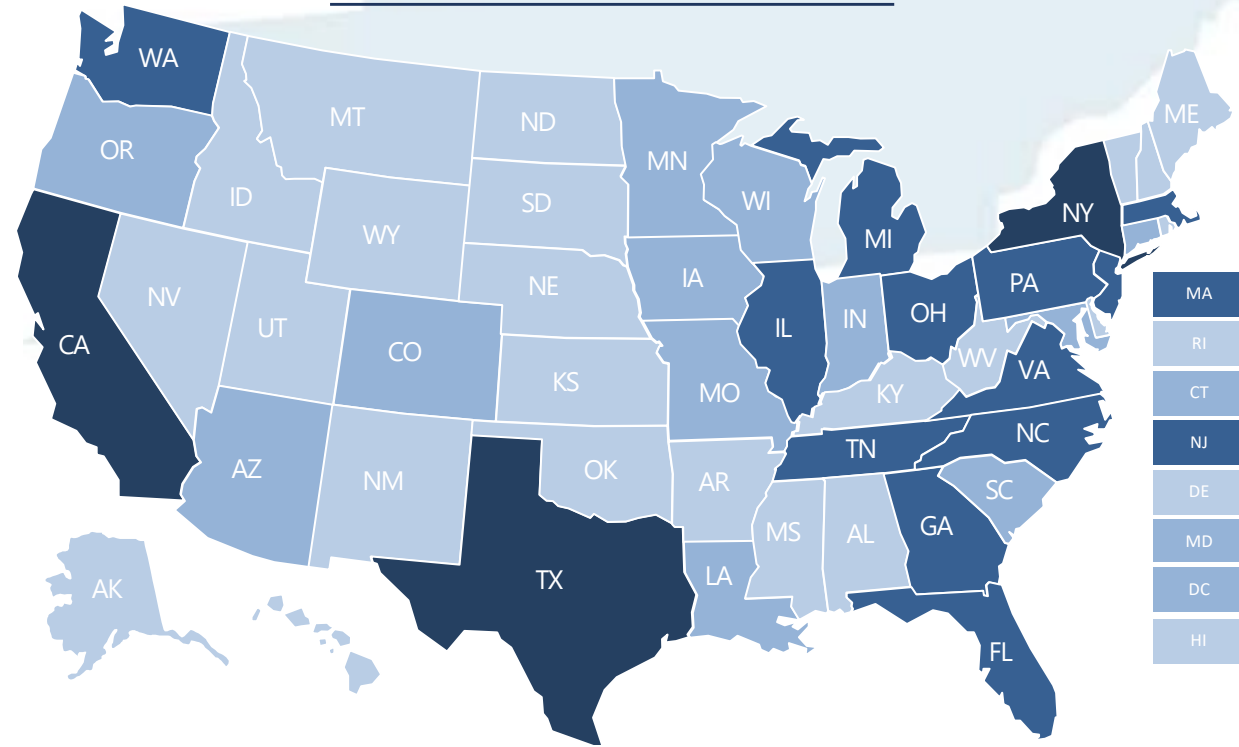
In the U.S. over **\$1 trillion** in capital goods is financed through loans, leases, and other financial instruments.
