

## EQUIPMENT FINANCE INDUSTRY IN VIRGINIA

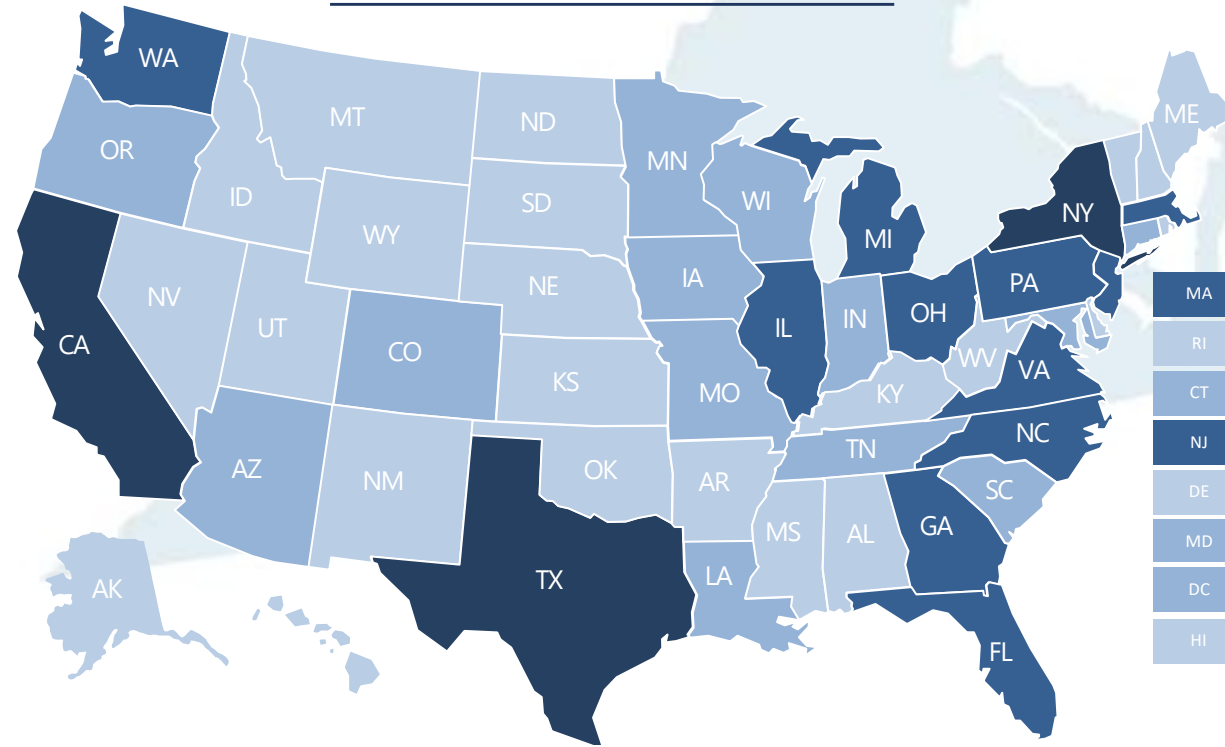
In the U.S. over **\$1 trillion** in capital goods is financed through loans, leases, and other financial instruments.

Businesses in the Commonwealth of Virginia financed **\$27.5 billion** in capital equipment in 2022.

Ranked in the **top 15** for the amount of equipment financed in 2022.

Natural gas accounted for **57%** of Virginia's total electricity net generation in 2021.
